



AGREEMENT AND WAIVER

Accountability and liability

1. I represent that I am the legal owner of the dog described above to use services provided by The Dog Circle Inc.
2. I understand that allowing my dog to participate in activities and services at The Dog Circle Inc. is not without risk to my dog. I hereby waive and release The Dog Circle Inc., its employees, directors, owners and agents from any and all liability which my dog may suffer, including specifically, but not without limitation, any injury or damage whatsoever arising from the dog attendance and participation of services provided by The Dog Circle Inc., or when the dog is on the premises.
3. I understand that I am solely responsible for any damages or injuries caused by the actions of my dog to other dogs, humans or object while my dog is in the care of The Dog Circle Inc., or on the premises of The Dog Circle Inc.
4. I agree to save and hold harmless, The Dog Circle Inc., its employees, directors, owners and agents from any and all claims by any member of my family or any other person accompanying me to a function of The Dog Circle Inc., or while attending the premises of The Dog Circle Inc., as a result of any action of any dog.
5. The Dog Circle Inc. reserves the right to temporarily or permanently remove a dog from care at any time, or refuse service to any dog to ensure the safety of staff and other dogs.

Health and well-being

1. I certify that my dog is in good health without any acute illness or injury, and I agree to fully disclose to The Dog Circle Inc. any health problems that my dog develops, as soon as I am made aware.
2. I understand that a veterinary clearance letter may be required before returning to The Dog Circle Inc. if my dog has been diagnosed with a communicable disease within the past 30 days.
3. I understand the health of my dog is my responsibility. I certify that my dog is up to date on all required vaccinations (distemper, parvovirus and rabies) and will continue to ensure all vaccinations are up to date for as long as my dog attend The Dog Circle Inc.; I am aware that bordetella vaccine is recommended, but not mandatory.
4. I affirm that my dog has not shown aggression or threatening behavior towards any other person or any other dog.
5. I understand the risks of allowing my dog to participate in a mixed dog environment. I agree that The Dog Circle Inc. and their caregivers will not be held liable for any illness, injury, running away or death while my dog is in the care of The Dog Circle Inc.

6. I understand and agree that any medical problem that develops with my dog while in the care of The Dog Circle Inc. will be treated as deemed best by The Dog Circle. In the event of an emergency and The Dog Circle Inc. is unable to reach me, or my emergency contact, at any of the phone numbers provided, I authorize The Dog Circle Inc. and/or a licensed veterinarian to provide necessary medical care and I assume full financial responsibility for any and all expenses incurred.

Social media

1. I give permission that my dog may be photographed, videotaped and/or recorded, and The Dog Circle Inc. shall be the exclusive owner to the results and all proceeds of such media.
2. I agree that photographs, videos and any recordings of my dog, my dog's name and my first name may be used for advertising, publicity or any business purposes.
